1.0 INTRODUCTION

1.1 PURPOSE OF THE PUBLIC INVOLVEMENT PLAN




Figure 1.1 I-526 and Long Point Road Interchange Project Process and Proposed Schedule

The I-526 and Long Point Road Interchange project Public Involvement Plan (PIP) details the strategies and tools that will be used to provide members of the public and stakeholders with key information about the project and opportunities to offer meaningful input on decisions that will affect their community. This PIP was developed to be consistent with public involvement requirements under the National Environmental Policy Act (NEPA), Title VI of the Civil Rights Act, Executive Order 12898 – Environmental Justice, and other federal regulations. This PIP outlines methods to engage all segments of the public, and other stakeholders, in and around the proposed project area. The PIP is a living document that can be adapted to incorporate new or more successful approaches as the project evolves and to document engagement as it occurs. Community input is critical to the success of any project, and the Federal Highway Administration (FHWA) and the South Carolina Department of Transportation (SCDOT) are committed to providing meaningful public involvement opportunities throughout the project development process (**Figure 1.1**).

2.0 OVERVIEW

2.1 OVERVIEW OF THE I-526 AND LONG POINT ROAD INTERCHANGE PROJECT


Long Point Road is the only point of access for the South Carolina Port Authority's (SCPA) Wando Welch Terminal (WWT). As a result, the Long Point Road interchange is the only option for trucks accessing the WWT from I-526. However, the interchange also provides access to homes, businesses, schools, parks, and industrial facilities along Long Point Road. The purpose of the proposed project is to improve the I-526 and Long Point Road Interchange to reduce congestion, address interchange deficiencies, and improve operations on the I-526 corridor located between the Wando River and Hobcaw Creek.

Analyzing the 2017 traffic volumes within the project area determined that the I-526 corridor currently operates under poor conditions west of Long Point Road (both east and westbound), and with no improvements, will operate under failing conditions by 2050. The need for improvements to the Long Point Road interchange was identified in the I-526 Lowcountry Corridor (I-526 LCC) EAST Planning and Environmental Linkages (PEL) study. It was determined that the current Long Point Road interchange does not have the capacity to accommodate future growth and provide acceptable traffic operations.

SCDOT is conducting an Environmental Assessment (EA) for the interchange of I-526 and Long Point Road shown in **Figure 2.1**. The EA will be written to follow the National Environmental Policy Act (NEPA) requirements established by the Council on Environmental Quality (CEQ) and the Federal Highway Administration (FHWA).

While providing opportunities for public involvement, the EA will confirm the purpose and need for the project, develop alternatives that meet the purpose and need (including an option to do nothing), analyze the potential environmental impacts of the alternatives, and identify a recommended preferred alternative for the I-526 and Long Point Road interchange.

Additionally, the EA will provide sufficient evidence and analysis for determining whether an Environmental Impact Statement is necessary or if the recommended preferred alternative would not be expected to have a significant impact to the environment.






2.2 COORDINATED OUTREACH EFFORTS

SCDOT has implemented protocols to avoid confusion of this project with other projects occurring in the Charleston region, including developing a separate website, branding, and messaging for the I-526 and Long Point Road Interchange project. Typically, each project will reference the other projects in its materials - highlighting the distinctions and pointing the user to the other respective projects. SCDOT is in the process of completing an Environmental Impact Statement (EIS) for the I-526 Lowcountry Corridor WEST (I-526 LCC WEST). A separate, but distinct project, the I-526 LCC WEST extends from south of Paul Cantrell Boulevard (Exit 11) in West Ashley to Virginia Avenue in North Charleston. In addition, the Mark Clark Extension project is going through the NEPA process. The public engagement team will partner with SCDOT to align messaging across projects to maintain the overarching goals of this PIP and those established for the I-526 LCC WEST and the Mark Clark Extension projects.

2.3 PUBLIC INVOLVEMENT OUTREACH BOUNDARY

Although changes to a transportation network can be far-reaching, impacting mobility and travel patterns throughout a region, a reasonable boundary is needed to provide guidance for focused public involvement and outreach efforts. Focused outreach efforts will follow the Town of Mount Pleasant neighborhood boundaries that intersect a 1,000-foot buffer around the project study area boundary, shown in **Figure 2.2**. Recognizing that this project affects the region as a whole, some outreach efforts will include broader, regional reach, such as newspaper advertisements and social media.







3.0 DEVELOPMENT OF THE PUBLIC INVOLVEMENT PLAN

This PIP is designed to provide a clear description of how SCDOT will: solicit input, develop two-way communication with communities, local citizens, stakeholders, and other interested parties and document public opinions regarding the I-526 and Long Point Road Interchange project.

Public engagement will follow all NEPA requirements. As required by the Safe, Accountable, Flexible, Efficient Transportation Act: A Legacy for Users (SAFETEA-LU) Section 6002, the public will be provided with opportunities to provide specific input on the purpose and need statements, as well as the range of alternatives. This project-specific PIP outlines the public's opportunities for engagement in the project development process and strategies for encouraging public input, as required by NEPA.

3.1 BRANDING

Project branding is critical to ensure the I-526 Lowcountry Corridor projects' identities, including the I-526 and Long Point Road Interchange, are separate from myriad efforts also underway in the Berkeley-Charleston-Dorchester region. The logo developed for the I-526 and Long Point Road Interchange project will be the cornerstone of the project's branding and the 'look and feel.' As a resultant project of the I-526 Lowcountry Corridor EAST, the I-526 and Long Point Road Interchange project logo reflects that relationship while also providing a unique identity for this NEPA project.



3.2 INTERESTED PARTIES

The interested parties list for the I-526 and Long Point Road Interchange project builds on the interested parties list for the I-526 LCC EAST. This list is not all-inclusive—as interested parties are identified, they are added to the list. Interested parties may opt-in to receive project updates online or at public meetings. The interested parties list is available in Appendix A.

3.3 KEY MESSAGES

Several key messages will be emphasized to the public throughout the project. Currently approved key messaging includes:

- An EA is being prepared for the I-526 and Long Point Road Interchange project which will build on the initial analysis and public input received during the I-526 Lowcountry Corridor (LCC) EAST Planning and Environmental Linkages Study (PEL).
 - The I-526 LCC EAST PEL defined the transportation challenges and range of possible alternatives for the I-526 LCC EAST Corridor. The I-526 and Long Point Road Interchange project is a result of those alternatives evaluated during the I-526 LCC EAST PEL.
 - Because this interchange serves as a major economic connector in the lowcountry, linking the goods that flow to and from South Carolina's busiest port terminal with I-526 and other integral components of the state's freight network, these factors must be taken into consideration with any planning efforts.
- The project team looked at a series of strategies that focus on operational improvements without the need for expansion, known as Transportation Systems Management and Operations (TSMO) strategies, during the I-526 LCC EAST PEL.

Additional key messages are intended to support the goals of the PIP:

- This project is an objective process to help determine what actions, if any, are needed to best serve the transportation needs of the area.
- Before a major highway project can be constructed, FHWA requires the completion of an environmental study.
- FHWA and SCDOT encourages the public's participation and will actively seek out and engage all who may be affected.
- The public has a voice in the decision-making process, and FHWA and SCDOT will listen to and consider all input.
- While this process does not include a public vote, all comments received are reviewed and considered and will likely result in refinements in the project.

October 2022 Update:

Key messages developed in response to comments received during the summer 2022 public information meeting comment period include:

• The purpose of the proposed project is to improve the operations of the I-526/Long Point Road interchange and I-526 mainline and reduce operational conflicts between port-related and local traffic.

- The average daily number of vehicles, including cars and commercial vehicles, driving through the I-526/Long Point Road interchange is expected to grow 66% by 2050. 13,000 more truck trips per day are anticipated on I-526 west of the Long Point Road interchange by 2050.
- The designs presented at the public information meeting are conceptual and still subject to change as the designs are refined. The new access ramps are being designed to accommodate the planned widening of I-526 and must conform to the design standards set by FHWA and SCDOT for interstate facilities. Based on comments and feedback received during the public comment period, the design of the proposed port ramps is being refined, where feasible, to avoid or minimize potential residential relocations and community impacts.

3.4 DEMOGRAPHICS




Figure 3.1 Public Involvement Outreach Area and Block Groups

The community can be better understood by collecting demographic information. Census data is used to understand the demographics of the various potentially impacted communities. The block groups expand further than the focused outreach area as shown in **Figure 3.1**.

The total population of the block groups that comprise the study area is roughly 15,000 people. **Table 3.1** shows the block groups comprising the focused outreach area compared to national-, state-, county-, and city-level data. Block Group 1, Census Tract 46.14 has a population of 2,856. Of this population, 20.7% are minority, including 15% African American and 2.3% Hispanic, the highest minority population of the six block groups that make up the study area. There is also a 0.6% limited-English population (LEP) in this block group. This is the only block group within the study area that has a limited-English population. Four of the six block groups that comprise the study area have a Hispanic population of roughly 2.5%, including Block Group 1, Census Tract 46.14, Block Group 2, Census Tract 46.14, Block Group 2, Census Tract 46.22, and Block Group 3, Census Tract 46.14. Additionally, Block Group 3, Census Tract 46.14 has a 3% population living below the poverty level. Each of the block groups that make up the study area has a population of 1% or less living with limited internet access. Compared to national, state, and county demographics, the six study area block groups have fewer minorities, limited-English populations, and individuals living below the poverty level.

While this data shows that overall, the demographics of this community reflect a more affluent, collegeeducated, English-speaking, middle-aged demographic, consideration will be given to capture and inform the minority population, as well as the elderly and those who have beginner's permits/drivers licenses (ages 15-17).

Other notable community characteristics include three of the block groups, Block Group 1, Census Tract 46.14 Block Group 2, Census Tract 46.22, and Block Group 1, Census Tract 46.12, have an 18% population of adults 65 or higher. This is slightly higher than the national, state, and county demographics. Additionally, two block groups, Block Group 1, Census Tract 46.14 and Block Group 2, Census Tract 46.14, have a 27% population of children 17 or younger. The project team will consider these community characteristics as materials are developed for these communities to increase accessibility. More information on how these communities will be reached can be found in **Section 5.0 Public Outreach Tools.**

Table 3.2 identifies a list of communities, churches, recreational facilities, schools, and businesses within the outreach boundary as of spring 2022. These organizations may be reached through the methods discussed in **Section 5.0 Public Outreach Tools.**




4.0 GOALS AND STRATEGIES OF THE PUBLIC INVOLVEMENT PLAN

4.1 GOALS AND STRATEGIES

Because public involvement is a critical component of the transportation planning process, engaging the public at the very early stages will help ensure decisions are made in consideration of, and to benefit public needs and preferences while developing potential alternatives for the proposed project area. The public involvement effort is intended to establish and maintain communication between the community and SCDOT regarding issues and concerns surrounding the I-526 and Long Point Road Interchange project. The public involvement goals and associated strategies are identified below.

5.0 PUBLIC OUTREACH TOOLS

SCDOT uses a multi-layered approach to engagement, pairing audiences with the techniques that will best suit their needs. The methods SCDOT is currently leveraging for the I-526 and Long Point Road Interchange project are listed below. Regardless of purpose or methodology, each method will comply with the established messaging for the project. All materials used in the public involvement effort will be approved by SCDOT before they are disseminated.

5.1 PROJECT WEBSITE

A project website, <u>www.526LCCLongPoint.com</u>, will be used to disseminate project information, provide a schedule of events and studies, and solicit public input. The site includes English and Spanish materials and includes features such as an online feedback form, a location for media information, and technical documents and reports. The website will undergo an ADA accessibility check. The website will continue to be updated on a regular basis with the intent of providing real-time project information for the community as new information becomes available. This website will link back to the I-526 Lowcountry Corridor project website (<u>www.526LowcountryCorridor.com</u>) and the PEL efforts in a clear way.

Website Performance Metrics and Highlights

The I-526 and Long Point Road Interchange project website will track user activity and measure engagement through the following metrics:

- Total number of sessions
- How website is accessed (percent of users accessing website by typing in URL directly, shared links, etc.)
- How many people visited the website on a desktop, phone, tablet, etc.
- Pageviews of the Homepage and most visited page after the Homepage

October 2022 Update:

Website Performance Metrics and Highlights since Launch (June 12, 2022 through October 31, 2022)

- Total Sessions: 9,152
 - Average pageview time: 2:13 minutes
- Most (51%) traffic was direct (viewers typing in the website URL directly), followed by traffic from social media (21%)
- Most traffic (55%) was on mobile devices, followed by desktops (42%)
- PIM page received the most views (5,831) followed by homepage (5,380)

5.2 NEWSLETTERS & EMAIL BLASTS

The I-526 and Long Point Road Interchange project team will prepare newsletters and email blasts (electronic newsletters) at appropriate intervals for the duration of the project to engage the public. These newsletters will include information, presented in a visually appealing and engaging manner along with technical facts and contact information for the project manager. The newsletters will be distributed to residents in the study area via email or standard USPS mail and made available on the website and via social media. The newsletter will either include a link to a Spanish translation or be translated in Spanish.

The newsletters will be developed and distributed on an approximate quarterly basis coinciding with project milestones and public meetings:

- Volume 1 Newsletter Introduction to the project; public information meeting; Done (public meeting handout emailed as newsletter)
- Volume 2 Newsletter What we heard from the public information meeting and how the feedback will be used; Done (public meeting summary and FAQs emailed October 31, 2022)
- Volume 3 Newsletter Project update; introduction to the public hearing and recommended preferred alternative
- Volume 4 Newsletter What we heard at the public hearing and how the feedback will be used; project closeout

October 2022 Update:

Email Blasts

An eblast is an email message that goes out to a group of people in mass, simultaneously. In this case, the I-526 and Long Point Road Interchange Improvements project has a joint mailing list of interested parties with the I-526 LCC projects. Individuals may subscribe to receive email updates for these projects. Additionally, the I-526 and Long Point Road Interchange Improvements project has a separate list of local stakeholders which is used to inform them of stakeholder-only events.

- July 26, 2022: An eblast announcing the PIM (online and in-person) was sent to 2,448 recipients.
- July 26, 2022: An eblast announcing the PIM (online and in-person) and invitation to participate early at the in-person meeting was sent to 289 stakeholders.
- August 1, 2022: An eblast reminding interested parties about the in-person PIM was sent to 2,441 recipients.
- August 31, 2022: An eblast reminding interested parties about the end of the comment period (September 1, 2022) was sent to 2,554 recipients.
- October 31, 2022: An eblast with the public information meeting summary and frequently asked questions was sent to 2,600 interested parties.

5.3 POSTCARDS/ FLYERS

Postcards will be produced and used to notify residents and businesses within the focused outreach boundary about any upcoming public meetings. These will be distributed one to two weeks prior to the public information meeting and public hearing. Information on the postcards will include the time, date,

location, and detailed specifics about the upcoming meetings, including how to participate virtually and the availability of materials in Spanish.

Flyers may be placed in local businesses throughout the focused outreach boundary, along with flyers for distribution to customers. Ahead of the public information meeting and public hearing, flyers will be distributed at Town of Mount Pleasant properties using their digital signage. While there are no truck stops within the study area, flyers may be placed at regional truck stops to capture drivers using the interchange to access the Wando Welch Port Terminal. This material will be provided in both English and Spanish (where needed). The flyers would emphasize how the public can participate, why the public should attend these meetings, and what they will learn.

October 2022 Update:

<u>Postcards</u>

The project team mailed postcards to approximately 5,500 addresses within the focused outreach area to arrive at mailboxes around July 26, 2022 (the beginning of the virtual public information meeting).

Town of Mount Pleasant Digital Displays

The Town of Mount Pleasant shared a version of the PIM engagement flyer on their digital signage throughout the Town leading up to the PIM. Digital signage was located in community centers and Town facilities.



5.5 TRADITIONAL MEDIA

At key project milestones, the project team will provide project updates to specific media outlets.

- The local newspapers identified include the Post and Courier, the Moultrie News, El Informador
- Local television stations: the project team may seek opportunities for interviews on free and cable channels. This may include PSAs for Spanish-language stations. Personnel designated by SCDOT will be available for interviews to discuss issues, updates, and/or concerns regarding the project.

5.5.1 Media Relations

Media relations will play a key role in informing and educating the public. Briefings will be held at key decision points and at times when it is deemed necessary to disseminate information to the public. For instance, media will be coordinated for interviews in conjunction with the public information meeting and public hearing. Media monitoring will ensure an understanding of community perception of the project. Articles on the project will be saved and documented in the project file.

October 2022 Update:

SCDOT's Communications Office distributed a press release with the launch of the online PIM on July 26, 2022. Additionally, a media event was hosted on July 26, 2022 at the I-526 LCC Community Office to brief

5.5.2 Local Newspapers

The local newspapers identified include the Post and Courier, Moultrie News, El Informador.

Advertisements about upcoming public meetings will be placed in local newspapers (traditional as well as niche publications) and other relevant local publications to keep the community informed. The public involvement team has developed a list of newspapers that is diverse and relevant for the outreach area, including Spanish-language newspapers.

While there is a requirement to do a legal ad in the main local paper, a display ad format would be used in the other papers as display ads draw more attention, are often in a more prominent location of the paper, and can more quickly convey the key information related to engaging.

Example public notices and advertisements to be displayed in newspapers are below.

October 2022 Update:

Newspaper Advertisements

The project team placed advertisements in local area newspapers to notify people about the PIM. Advertisements were placed in the following newspapers:



6.0 PUBLIC OUTREACH EVENTS

6.3 ELECTED OFFICIALS MEETINGS

Local, state, and federal elected officials will be briefed when project events warrant, as determined by SCDOT. No elected official meetings will be initiated, scheduled, or conducted by the I-526 and Long Point Road Interchange project team unless directed by SCDOT.

Elected officials participation in the information-sharing process is important to the success of the project. The SCDOT Project Manager will send all elected officials notifications and emails with periodic project updates and announcing all public information meetings and stakeholder meetings. Specific briefings will be held, and/or notices issued, prior to public meetings to highlight what is to be presented to their constituents. Elected officials will also be copied on any correspondence distributed to stakeholders. It is envisioned that this is an opportunity for elected officials to provide feedback on the project information they receive in the meeting and provide guidance to SCDOT and the project team on opportunities to engage their communities in a meaningful way. Their feedback will result in an update to the community engagement program, as needed.

The project teams will coordinate with local officials from Mount Pleasant and Charleston County.

6.4 NON-GOVERNMENTAL ORGANIZATION (NGO) MEETINGS

NGOs include entities such as Rotary Clubs, professional societies, environmental interest groups, and chambers of commerce. NGO outreach is another means to inform, educate, and involve the public. It also adds credibility to the project by demonstrating that SCDOT is interested in and wants to hear what people have to say. Outreach or engagement activities with planning organizations, NGOs, quasi-state agencies, and public authorities will be identified and requested prior to engagement efforts. These efforts will be tracked within **Section 6.2** above related to the Speakers Bureau.

6.5 ONLINE MAPPING TOOLS AND ONLINE STORY MAPS

Online engagement tools are becoming the quickest, easiest and most cost-effective way to reach a large number of people and maximize inclusiveness. Interactive mapping tools allow people to: identify routes, resources, and places of interest; leave comments; agree/disagree; and upload photos. Story maps are a means of visual storytelling. Story maps provide an interactive visual experience for non-technical audiences. Various uses of mapping tools will be explored, and if deemed usable, may be implemented by the project team.

6.6 PUBLIC INFORMATION MEETINGS (PIMs)

There will be one public information meeting (PIM) conducted during the EA. A public notice will be prepared for the newspaper and postcard mailings will also be distributed notifying the public of the meeting date, time, and location one to two weeks ahead of the meeting.

The purpose of the PIM is to explain how public input will be used to inform the concepts development and screening process, ask for public input on the Reasonable Alternatives, and outline the next steps in the project development process.

Additionally, SCDOT wants to gather information from the public, resource agencies, and project stakeholders on any resources in the study area including historic or cultural resources in the area. The information presented and handouts made available at the PIM will be available in both English and Spanish. Translators will also be available on site to help guide Spanish-speakers through the materials.

This drop-in, open-house meeting will not have a formal presentation. Content will be designed to educate the public about potential improvements in the project area, analysis done to date, and how their previous input has been used. Additionally, the meeting will be designed to receive input from the public.

The public will have multiple ways to submit comments: through the project website's virtual PIM webpage or general contact page (<u>www.526LCCLongPoint.com</u>), email comments directly to <u>info@526LowcountryCorridor.com</u>, mail to Joy Riley, SC Department of Transportation, Post Office Box 191, 955 Park Street, Room 401, Columbia, SC 29202, and in-person at the public information meeting. A formal comment period will be announced, and all comments will be counted at the close of the formal comment period. The project team will count the number of comments received through each media, and report on the top comments or concerns that arose throughout the formal comment period.

October 2022 Update:

Summer 2022 PIM

The PIM was held on August 2, 2022 at the RL Jones Center in Mount Pleasant, SC. 301 people attended this meeting, and 48 in-person comments were received. Project stakeholders were invited to attend the meeting at starting at 4 p.m., and the general public was invited to attend from 5-7 p.m.

- The purpose of this public information meeting was to:
 - Explain how input in the I-526 LCC EAST study was used to accelerate this project
 - Ask for your input on the purpose and need and the range of alternatives
 - Outline the next steps in the project development process
 - Gather information on historic or cultural resources and any potential impacts
- The handouts available at the PIM were available in both English and Spanish. Translators were also available to help guide Spanish-speakers through the materials.
- In-person materials included static boards and roll plots. The layout included sign-in tables at the entrance of the gym, static boards arranged around the perimeter of the gym, and roll plots of the alternatives located in the center of the gym. The boards/stations around the perimeter of the gym included:
 - 1. Moving from the PEL to NEPA Process
 - 2. Draft Purpose & Need
 - 3. Anticipated Traffic Growth (two boards)
 - 4. Screening Process
 - 5. Range of Alternatives (two boards showing six alternatives)
 - 6. Noise Evaluation Process
 - 7. Vegetative Maintenance
 - 8. Typical Right-of-Way Process

The alternatives displayed on the roll plots were:


- 1. Alternative 1A: Improved Existing Ramps
- 2. Alternative 2: New Port Access Ramps with Improved Existing Ramps
- 3. Alternative 3: Diverging Diamond Interchange (DDI)
- 4. Alternative 6: New Port Access Ramps with Diverging Diamond Interchange (DDI)

<u>Comments</u>

- The project team received 538 comments from this PIM
 - 309 through the project website
 - 164 through email
 - 48 in-person at the PIM

- 7 on the general I-526 website
- 3 through mail
- 6 from stakeholders
- 1 from an agency
- Comment responses were sent to all people who made comments in October 2022.
- Alternative 2 is the alternative for which the most support was voiced as well as the most opposition. 19.3% of respondents stated that they supported the creation of new port access ramps, and 27.9% of respondents said that they did not support the addition of new port access ramp. Traffic, safety, noise, and truck traffic concerns were all frequently noted. Concerns with the removal of the existing left turn onto Belle Hall Parkway and neighborhood impacts were voiced primarily by residents of the neighborhoods to the northeast of the interchange. Fewer residents of the neighborhoods to the west of the interchange commented, but those who did were generally supportive of the project and the new port access ramp concepts.

6.7 VIRTUAL PUBLIC INFORMATION MEETING

A virtual public information meeting will be conducted during the appropriate stages of project development, likely in concurrence with the in-person PIM. The virtual meetings will afford the public the opportunity to participate in a public meeting from anywhere and anytime during the official public comment period. This provides additional flexibility for those members of the public with scheduling or transportation challenges to participate, as well as those members of the public not traditionally comfortable with government settings.

SCDOT will want to gather information from the public, resource agencies, and project stakeholders on any resources in the study area that have historic or cultural resources. The information will be presented in both English and Spanish.

Specific metrics will be tracked during the formal comment period while the Virtual PIM is available. Metrics include:



- 744 people completed the survey in English
- 1 person completed the survey in Spanish

6.8 PUBLIC HEARING

There will be one public hearing conducted during the Environmental Assessment (EA) where the recommended preferred alternative and EA will be presented. A public notice will be prepared for the newspaper and postcard mailings will also be distributed notifying the public of the public hearing's date, time, and location two weeks ahead of the meeting.

Materials will be prepared in English and Spanish, and a Spanish translator will be available at the public hearing. Materials will include a meeting handout and displays showing the recommended preferred alternative and potential impacts. The public hearing format will consist of an in-formal open house meeting followed by a formal presentation and verbal comment session.

An on-demand virtual public hearing will complement the in-person public hearing and feature a webpage with materials that the public can access on their schedule. The online materials will mirror the in-person public hearing and can reach a larger, more diverse population. Virtual meetings provide the public with more flexibility in both their schedule and location.

Comments will be accepted online, in-person, by email, and by mail. After the end of the public comment period, each person who provided a written comment will receive a response.

6.9 ADDITIONAL OUTREACH OPPORTUNITIES

- Coordinate with the local senior citizen and disability coordinators to assist in conducting group meetings at local senior centers.
- Coordinate with local homeowners' associations (HOA) to publish project information in their community newsletters or attend HOA meetings to provide project updates.
- Create customized, free PSAs for Spanish-speaking radio stations to specifically reach LEP communities, particularly AM stations (Regional Mexican, Spanish Contemporary).
